SOC 2 is a voluntary compliance standard which specifies how organizations should manage customer data. The standard is based on the following Trust Services Criteria: security, availability, processing integrity, confidentiality and privacy. Certification supports Penn River's dedication to providing the highest level of privacy and security standards and helps mitigate risks and continue to improve processes.



SOC 2 Type 2 certification means that Penn River has undergone an independent audit of its controls related to security, availability, processing integrity, confidentiality, and privacy, and the auditor, Prescient Assurance, has confirmed the operational effectiveness of these controls. This certification provides assurance to customers and stakeholders that Penn River has implemented adequate controls to protect their data and ensure the security and privacy of their systems and services.

HIPAA compliance signifies that Penn River has been evaluated for its adherence to the Health Insurance Portability and Accountability Act's (HIPAA) regulations regarding the security, confidentiality, and integrity of protected health information (PHI). This entails implementing robust controls to safeguard patient data, ensuring its availability when needed, and maintaining its confidentiality and privacy. Undergoing an independent audit ensures that Penn River's controls align with HIPAA standards, providing assurance to customers and stakeholders that their sensitive health information is adequately protected. This compliance underscores Penn River's commitment to maintaining the highest standards of data security and privacy within its systems and services, fostering trust and confidence among patients and partners alike.
